Finally, while the Editorial Board is relatively young (it was established in 2010), it has already produced a wide-ranging collection of publications in collaboration with numerous international partners, under the conceptual direction of Professor Stefan Huber and Professor Carlos, Carmen Lull. We have published articles relating to history of the Spanish law, European and Latin American law, the history of the Church, history and canon law, the history of the International Criminal Tribunal, and the history of law. In addition to the publishing house, we have undertaken other forms of activities in the fields of organisation and operation. In a series of works carried out in close collaboration with the Chair of Latin American and Caribbean Studies of the University of York, a group of PhD students (Juan Carlos Eslava, Miranda Jou and Raquel Martinez Solares) have developed a collaborative project called *Disciplina, talento y manejo de la lengua* (Discipline, Talent and Language Management) [Eslava, Jou and Martinez Solares, *Disciplina, talento y manejo de la lengua. Estudios de diálogo en la madurez hispánica de la segunda mitad del milenio*, 2018, p. 1-47]. The aim of the project is to fill the existing gaps in the analysis of the Hispanic language management in the late modern period by developing, for a particular national and regional context, a cross-disciplinary perspective that aims to revise the often exaggerated role that the regional characteristics of the language have in the formation of the native language of readers and writers. The project has resulted in a book entitled *Lenguaje en áspero. The Research Field European Modernity deals with the project

series on modernity which has its roots in the Journeys to Europe report (2014-2017), and was a project meant to characterise European modernity as a concept and to explore 'original' or 'taken-for-granted' modernity as an object of legal scholarship (see the reports of Bragagnolo, Arron Banks, Birr, Gironda, Spahn, and the contribution of John Masson Smith to this volume). This project has been carried out in four components: narrative analysis and qualitative description; canonical texts; soft data analysis; and research on institutions. This Project has been developed in close collaboration with the Research Group on Legal Historiography. In both cases we have used existing technical and methodological approaches for the analysis of narratives (see especially Moltes et al.), as well as for the analysis of historical legal materials (Pogies, Spahn). As part of our research project "European Conciles sacramentorum", we will attempt to trace the development of new canon law from the twelfth century onwards.

In particular, we will investigate whether the liturgical and theological transformations of the conciliar era have had an influence on canon law, how they have affected the nature of canon law (and, in particular, ecclesiastical liberty), and, most importantly, how this might influence the reform of canon law undertaken by councils of later centuries. We are currently gathering oral histories, particularly from the famous University of Salamanca, of the most significant cases brought before the European Court of Justice in this period. Other studies of relevance include the involvement of the Spanish monarchs in imperial affairs during the period, as well as efforts to harmonise canon law. From the sixteenth century onwards, complex questions such as the defence of right to life and self-defence, seditious libel, and the protection of the family have played a very important role in the formation of European freedom of expression standards, and recent research is now beginning to unravel the historical origins and development of these. 5ec8ef588b
