the "sudden roadblock" provision permits a traffic stop to be declared a "roadblock" if a police officer enters a vehicle, or otherwise blocks access to a vehicle, and requests that the driver stop and provide the information necessary for the officer to decide whether or not to issue a citation. the "sudden roadblock" provision is similar to the "roadblock" or "sheriff's roadblock" provision that was in effect for commercial vehicles prior to the enactment of the new law, the "backroad" provision prohibits a police officer from directing a driver to enter a private road, driveway, cul-de-sac or other private property by directing the driver to enter or exit a roadway or street that is not open to the general public, and that does not have a sign directing the driver to enter or exit that private road, driveway, cul-de-sac or other private property. under the new law, a police officer may not direct a driver to pull off the roadway or exit the roadway except to perform an emergency operation, the hearing officer is not authorized to decide whether the evidence is sufficient to support a charge that the driver violated this provision, that determination is up to the district attorney's office, the new law also provides that the police officer must record the result of the traffic stop, including the issuance of a citation, and whether the officer issued a warning or, if not, whether the driver was issued a citation, the new law contains provisions that are intended to prevent potential abuses, in particular, the new law adds a provision to section 13a.38, indicating that the police officer must record any confidential information that the officer obtains as a result of a traffic stop, in addition, the new law requires the police officer to record the fact that a driver is asked to submit to a chemical analysis if the officer requests that a driver submit to a chemical analysis, prior to the enactment of the new law, all of the above requirements were contained in the "sudden roadblock" statute.

the texas department of transportation (txdot) launched an expansion project in may 2016 to replace and upgrade 17,000 feet of conveyor belt at the h&m landing in beaumont, texas. the project involved constructing a new conveyor, including a new 20-foot conveyor section, and upgrading the existing 40-foot conveyor. the project was completed in july 2016, and involved working during nighttime hours and handling hazardous materials at night. truck drivers needed to transport hazardous materials to and from the site throughout the project. during the project, the line was shut down twice and drivers were required to change their route each time. drivers also had to work alternate routes to avoid the project site. today, the u.s. department of labor (dol) and the u. department of transportation (dot) proposed a rule that would require motor carriers to provide

electronic data to the government regarding driver hours of service. electronic data would be collected for drivers, including the number of hours they drive, with the intent that the data be used for regulatory purposes. the rule applies to carriers that transport passengers, cargo or both. the hearing will be held in the hearings division and is conducted by an administrative law judge. an administrative law judge is a neutral hearing officer with no connection to driver control, and is selected from an available pool of attorneys within the department of public safety. the license will be valid for six (6) months. the license will not be approved if the documentation does not indicate that the driver is currently employed or has a valid driver license. if you have an outstanding ticket or any other restraint action, you must contact driver control prior to renewal to ensure that your license is current and valid. if driver control needs to contact you, you will need to contact the hearings division at 303-205-5606. 5ec8ef588b
